



**LIBERAL STUDIES PROGRAM
PART-TIME LECTURER POSITION**

The Liberal Studies Program at the University of California, Riverside, seeks a Lecturer to teach LBST 20W, its new writing intensive course, “Writing Across the Disciplines in Liberal Studies,” for the Spring 2023 quarter. Spring 2023 quarter begins March 29, 2023 and ends June 16, 2023.

This lower-division course will serve both Liberal Studies majors and students across CHASS fulfilling a writing requirement; it will be supported by workshops in the “Writing Across the Curriculum” program and discussion sections led by Teaching Assistants. The course aims to introduce undergraduates to writing conventions across the College of Humanities, Arts, and Social Sciences, preparing them for successful written work in upper-division courses.

Salary: See table [Pre Six Academic Year](#) for the salary range for this position. All new pre-six lecturer appointees are appointed at point 1. The salary for this position will be \$7146 per course taught. (pending final budget approval).

Qualifications:

Candidates should have minimum qualifications of an M.A. degree in a related field, with one year of teaching experience at the college level and a commitment to teaching excellence. We are especially interested in candidates with a demonstrated ability to work across multiple disciplines and guide students to develop discipline-specific writing skills across the humanities, social sciences, and arts. An ability to lead a team that will include Teaching Assistants and a commitment to diversity are important considerations as well. A Ph.D. is a preferred qualification, but candidates that have attained ABD status will also be considered. In addition, preference will be given to internal prior Pre-Six candidates.

UCR is a world-class research university with an exceptionally diverse undergraduate student body. Its mission is explicitly linked to providing routes to educational success for underrepresented and first-generation college students. A commitment to this mission is a preferred qualification.

Application Procedure:

Provide a cover letter that specifies your qualifications for the course you are applying for, curriculum vitae, Statement of Teaching, Statement of Contributions to Diversity, recent teaching evaluations taught at the college or university level, and 3 letters of reference that assess teaching ability. Materials should be uploaded using UCR's on-line application system.

Review of applications will begin on March 3, 2023 and may continue until filled. To ensure full consideration, applications and supporting material should be received by March 3, 2023.
